### Register name

Product Contact Point for Construction

### General description of the register

Article 10 of the Construction Products Regulation (EU) 305/2011 provides for Product Contact Points for Construction. Each Member State must designate a Product Contact Point for Construction in their territory to provide economic operators and the competent authorities of another Member State with information on the construction legislation applicable in their territory. The contact details of companies/persons are only used to answer their questions. The register is kept based on the Construction Act (751/2023, section 190).

### Grounds for processing

Compliance with a statutory obligation.

### Personal data content

Name; Phone number; Email address; Company/Organization

### Purpose for processing personal data

Name: personal identification, service of notice, communication

Telephone number: communication, obtaining additional information

Email address: service of notice, communication

Company/organisation: additional information for customer service

### **Personal data retention period**

Identifiable personal data is stored for as long as they are needed in the activities of the Product Contact Point for Construction.

### **Regulatory and other sources of data**

Person being registered.

### **Regulatory disclosures of data**

Inquiries outside the competence of the Product Contact Point for Construction are referred to the competent authority.

### **Other disclosures of data**

Public personal data may be disclosed to those requesting it in accordance with the Act on the Openness of Government Activities.

### **Transfer of personal data to third countries and international organisations**

Personal data is not transferred to any third countries or international organisations.

### **Recipient groups of personal data**

Persons making an information request

### **Right of access**

The data subject has the right to be informed of how their personal data is being processed.

### **Right to request erasure of data**

The data subject does not have the right to have the controller erase their personal data as the processing is necessary for compliance with a legal obligation.

### **Right to require restriction of processing**

The data subject does not have the right to request the restriction of the processing of their personal data.

### **Right to data portability**

The data subject does not have the right to transfer data to another controller as the processing is not based on consent or an agreement.

**Right to object**

The data subject does not have the right to object to the processing of their personal data.

**Automated individual decision-making and profiling**

No automated decisions or profiling are made based on the data in the register.

**Notification of a personal data breach to the data subject**

If a personal data breach is likely to result in a high risk to the rights and freedoms of the data subject, Tukes must inform the data subject of the personal data breach without undue delay.

**Consequences of failure to provide data**

Communication may become more difficult.

**Right to lodge a complaint with a supervisory authority**
