Purpose of the processing of personal data

Personal data retention period

Personal data will be deleted two years after an order has been placed.

Regulatory and other data sources

The person being registered.

Regulatory data disclosures

No regulatory disclosures of data.

Other disclosures of information

Public personal data may be disclosed to a person submitting a data request pursuant to the Act on the Openness of Government Activities.

Transfer of personal data to third countries or international organisations

Personal data will not be transferred to any third countries or to any international organisations.

Recipient groups of personal data

Persons submitting data requests, the police.

Right of access

A data subject may ask Tukes whether their personal data has been entered in a Tukes register, and if such data exists, what kind of information has been registered (data subject's right to obtain access to the information) The data subject may ask for any inaccurate or erroneous data to be rectified.

Right to request erasure of data

The data subject shall have the right to demand that the controller erase any personal data concerning him or her. The data subject shall have the right to cancel his or her consent at any time.

Right to restrict processing

If the data subject contests the accuracy of their personal data, they may request that the processing of their personal data be restricted until Tukes has verified the accuracy of the data.

Right to data portability

The data subject does not have the right to transfer the data to another controller because the processing is based on consent or an agreement.

Right to object

The data subject does not have the right to object to the processing of their data.

Automated individual decision-making, including profiling

No automated decisions or profiling will be made on the basis of the data in the register.

Notification of a personal data breach to the data subject

If the personal data breach is likely to constitute a high risk to the data subject's rights and freedoms, Tukes must inform the data subject of the personal data breach without undue delay.

Consequences of failure to provide data

If this information is not provided, Tukes cannot deliver the products to the customer.

Right to lodge a complaint with a supervisory authority
