








Minerals strategy



Background:

- Finland's previous minerals strategy was created in 2010.
- Need to update the strategy was recognised because of societal and global changes such as the growing need for raw materials (green transition & digital transition) and the changing geopolitical landscape.
- → The update is based on the programme of Prime Minister Petteri Orpo's Government, lead by the Ministry of Economic Affairs and Employment.
- → The strategy is to be completed by the end of 2024.

Aim of the update



The aim is to create a common understanding of the situation of the Finnish mineral cluster and the related policy objectives and main priorities.

The key target is **to promote the growth of the Finnish mineral cluster** in order to strengthen the **clean transition** and **Europe's strategic autonomy.** Besides this, the strategy aims to **increase the value** added of raw materials from the mining industry."

Process



- The work started when the ministry appointed a steering group in December 2023
- The steering group oversees and guides the project and it consists of representatives from the public sector, private sector, academia & environmental organisations
- The first phase was to invite together subgroups to work on the following themes:
 - 1. Minerals Policy and Regulation
 - 2. Investments and Financing
 - 3. Research, Development and Innovations
 - 4. Competence and Workforce
 - 5. International Cooperation, Competitiveness, and Export Potential of the Mineral Cluster
 - 6. Circular Economy
 - 7. Environment, Sustainability and Social License
 - 8. Security of Supply for Finnish Industries
- → Each of the subgroups drew up a report on its theme these reports work as the basis for the strategy.

- Strategy to set out a vision and 4-6 policy goals
- Each policy goal would then be further broken down into more concrete actions to be taken in order to reach each specific goal
